Why become an umpire?

- 1. You are a parent your child needs you! (To support them get them food, travel for tournaments ... and then you are stuck in a gym for a whole day and you are driving each other crazy!)
- 2. You get the best seat in the house for the best matches!
- 3. You love this sport and you really want to help make more good badminton happen in your area.
- 4. Improve your own game:
 - a. You will really learn all the Laws in detail and understand why, for example, your 'perfect' winning serve gets faulted when there's an umpire on court!
 - b. You will learn what umpires can and cannot do; when and how to ask for an umpire if you have a problem on the court; what to do if you disagree with an umpire's ruling; etc.
- 5. Umpires are totally cool (well, we like to think so).
- 6. There are definitely other reasons as well, but these are excellent ones to start. By the way, you likely will never learn the others until you become one ©

This course is being held prior to the <u>2023 YONEX SPBA Midwest Open Regional (May 27-29)</u>, which will serve as an excellent opportunity for trainees to have full on-court training. It is an excellent opportunity to develop technical official skills while helping an important event run smoothly and to work with a corps of experienced court officials. **This is the biggest and highest level junior badminton event in the Midwest region with 526 participants this year.** It should be a very exciting event with top Junior National players flying in. We will be using 27 courts, depending on the number of entries. This will require a tremendous amount of coordination and help from regional umpires. We are asking for your help umpiring or scorekeeping at the event after the clinic. For those feeling sufficiently prepared, evaluations can be conducted as a part of this event and the written exam can be administered so that by the end of tournament weekend, you could become a fully accredited Regional Umpire.

While junior parents and coaches are strongly encouraged to participate in this training, we are looking for others from the broader badminton community to participate as well –there will be many local opportunities to gain more experience in other junior and adult events in Illinois as well as in other parts of the Midwest Region. Becoming an umpire is one of the very best ways to support the continued growth of our great sport, supporting top quality, <u>on-time</u> competitions.



REGIONAL UMPIRE TRAINING - OVERVIEW

Purpose: Impart the necessary information about laws of badminton, role of umpires and other technical officials, required tools, use of scoresheet and training on proper language and other aspects of court management to those who wish to become certified USAB Regional Umpires.

Program: The clinic's four parts (below) may be conducted all in one session or in separate sessions. Anyone is eligible for the clinic but full certification is only available to current members of USA Badminton age 18 years or older.

- Classroom Instruction & Discussion This portion of the clinic is typically done first and may take from 1 to 3 hours, depending on the experience / preparation of the attendees.
- Written Test One-hour test testing knowledge of basic laws, proper language, understanding of game situations, sequence of actions and use of scoresheet. Trainees arrange with instructor to take this when s/he feels prepared for it; this may be done either before or after On Court Practical Training but should be prior to On Court Evaluation. Test must be passed with a minimum score of 80%.
- Practical (On Court) Training This generally involves demonstration, shadowing, support, observation
 and feedback as the instructor conducts training during actual matches covering language, calls,
 scoresheet markings, sequence of actions, use of stopwatch and skills needed for proper and effective
 observation of players and match situations. Initial matches may be recreational club play but training will
 proceed to actual tournament matches at the 2019 YONEX SPBA Midwest Open Regional May 26-28th
- On Court Evaluation This takes place at the 2023 YONEX SPBA Midwest Open Regional May 27-29th with observation conducted by either course instructor or a Tournament Referee as trainee umpires during multiple singles and doubles matches.

Upon completion of all segments of the program and documentation of current USAB membership, the instructor shall notify the Technical Officials Committee and recommend certification. Upon certification, a new umpire's USAB membership card will be updated to reflect this. USAB Umpire shirts may be available for purchase.

Fees: This course is provided free of charge by USAB as supported by annual membership fee. The course includes printed rules, course materials, tournament shirt, standard umpire gear (red / yellow cards), as well as dinner on the night of the clinic and meals during their assigned shifts during the tournament. Please bring a stopwatch with you to the course and tournament if you have one. We will also have some to borrow.

Prerequisites: Everyone: Participants should have basic knowledge about badminton, especially court layout, basic equipment and how the game is played and scored both in singles and doubles. Upon registering for a clinic, individuals will be expected to read (prior to the clinic) the Laws of Badminton as published by the Badminton World Federation.
